

CLOSED LICENSE AGREEMENT

PDF Teaching Use Only License

1. Purpose of this Agreement

The Licensor owns certain course materials, documents, guides, worksheets, assessments, and related educational content.

The Licensee has purchased access to the course materials under a Closed License, which allows the Licensee to use the PDF materials for teaching, training, facilitation, or educational delivery (**which the Licensee may charge for/profit from**), but does not allow the Licensee to copy, edit, rebrand, resell, or redistribute the materials as raw materials.

2. Licensed Materials

The “Licensed Materials” include the PDF course materials supplied by the Licensor to the Licensee, including but not limited to:

- PDF course manuals
- PDF learner guides
- PDF worksheets
- PDF assessments
- PDF rubrics
- PDF teaching or facilitation resources
- Any other non-editable PDF files supplied as part of the purchase

The Closed License does not include editable Word documents, source files, design files, templates, or any right to modify the original content.

3. Ownership of Intellectual Property

The Licensor remains the sole owner of all copyright, intellectual property rights, title, and interest in the Licensed Materials.

The Licensed Materials are licensed to the Licensee for limited use. They are not sold outright, assigned, or transferred.

The Licensee does not receive ownership of the content, copyright, structure, wording, design, layout, branding, or educational framework.

4. Grant of Closed License

Subject to payment and compliance with this Agreement, the Licensor grants the Licensee a limited, non-exclusive, non-transferable license to use the Licensed Materials for teaching, facilitation, training, coaching, or educational delivery.

The Licensee may:

1. Use the PDF materials to teach students, clients, groups, churches, teams, organisations, or course participants.
2. Provide the PDF materials to enrolled learners or participants as part of a paid or free teaching programme.
3. Print copies of the PDF materials for learners or participants enrolled in the Licensee's own class, workshop, course, coaching programme, or training session.
4. Display the PDF materials during live or online teaching sessions.
5. **Charge** learners or participants for the teaching, training, facilitation, coaching, or educational experience delivered by the Licensee.

5. Strict Restrictions

The Licensee may not:

1. Edit, alter, adapt, rewrite, redesign, or modify the Licensed Materials.
2. Remove, replace, or cover the Licensor's branding, copyright notices, logos, names, disclaimers, or identifying details.
3. Rebrand the materials as their own.
4. Claim authorship or ownership of the materials.

5. Sell the PDF materials as standalone products.
6. Resell, license, sublicense, or distribute the PDFs as raw materials.
7. Upload the PDF materials to public websites, marketplaces, template platforms, online stores, file-sharing platforms, shared drives, or public learning libraries.
8. Convert the PDFs into editable documents or recreate the content in editable form.
9. Copy and paste substantial portions of the materials into new documents, slides, manuals, websites, workbooks, or products.
10. Use the materials to create competing course materials, derivative products, private label products, or rebranded educational resources.
11. Sell, give, transfer, or assign this Closed License to any other person, business, organisation, school, ministry, or entity.

6. Teaching Use vs Raw Resale

The Licensee may sell access to a course, class, workshop, coaching programme, membership, or training experience where the Licensed Materials are used as part of the teaching.

The Licensee may not sell the Licensed Materials themselves as a digital product, downloadable product, resource pack, template pack, PDF bundle, course content package, or resale item.

In simple terms:

- The Licensee may sell teaching based on the materials.
- The Licensee may not sell the materials themselves as raw content.

7. Learner Access

The Licensee may provide the PDFs only to learners who are actively enrolled in the Licensee's course, class, programme, workshop, or training.

The Licensee must take reasonable steps to ensure learners understand that the materials are for their personal study use only and may not be copied, edited, uploaded, resold, rebranded, or redistributed.

Recommended learner notice:

These materials are provided for your personal learning use only. You may not copy, edit, rebrand, resell, upload, share, or distribute them without written permission from the copyright owner.

8. No Editing Rights

The Closed License does not include the right to receive or use Word documents, source files, editable files, design files, templates, or private label rights.

If the Licensee wants editing, rebranding, resale, or distribution rights, the Licensee must purchase an Open License from the Licensor.

9. Branding and Attribution

The Licensee must keep all Licensor branding, copyright notices, author names, logos, disclaimers, and identifying details intact unless the Licensor gives written permission otherwise.

The Licensee may describe themselves as the teacher, facilitator, coach, trainer, or course provider, but may not represent themselves as the creator or owner of the Licensed Materials.

10. Use by Employees, Contractors, or Team

Members

The Licensee may allow employees, contractors, facilitators, teachers, or team members to use the PDF materials only for the Licensee's authorised teaching activities.

The Licensee remains responsible for all use of the Licensed Materials by their team.

Team members may not copy, retain, sell, edit, rebrand, distribute, or use the Licensed Materials for their own separate purposes.

11. No Transfer of License

This Closed License applies only to the Licensee who purchased it.

The Licensee may not transfer this license to another person, business, organisation, church, school, ministry, trainer, coach, or company.

Each separate organisation or business must purchase its own license.

12. Payment

The rights granted under this Agreement become effective only once full payment has been received by the Licensor.

If payment is reversed, refunded, cancelled, disputed, or not completed, the license automatically terminates unless the Licensor confirms otherwise in writing.

13. No Warranty

The Licensed Materials are provided “as is.”

The Licensor does not guarantee any particular student result, business result, income result, spiritual result, personal outcome, professional outcome, or educational achievement.

The Licensee is responsible for how they teach, present, explain, and apply the materials in their own context.

14. Termination

The Licensor may terminate this Agreement immediately if the Licensee breaches any term of this Agreement.

Upon termination, the Licensee must:

1. Stop using the Licensed Materials.
2. Stop distributing the Licensed Materials to learners.
3. Remove the Licensed Materials from all online platforms under their control.
4. Delete or destroy all copies of the Licensed Materials, except where retention is legally required.
5. Stop promoting any course, workshop, or programme that uses the Licensed Materials.

15. Breach of License

Unauthorised copying, editing, rebranding, resale, public uploading, or distribution of the Licensed Materials may result in legal action.

The Licensor may pursue all available remedies, including damages, injunctions, takedown requests, marketplace complaints, recovery of legal costs where permitted by law, and any other remedies available under applicable law.

16. Limitation of Liability

To the maximum extent permitted by law, the Licensor will not be liable for indirect, incidental, special, consequential, or business losses arising from the Licensee's use of the Licensed Materials.

The Licensor's total liability under this Agreement will not exceed the amount paid by the Licensee for the Closed License.

17. Entire Agreement

This Agreement represents the entire agreement between the Licensor and Licensee regarding the Closed License.

No rights are granted except those expressly stated in this Agreement.

18. Acceptance

By purchasing, downloading, accessing, printing, teaching from, or distributing the Licensed Materials to learners, the Licensee confirms that they have read, understood, and agreed to this Agreement.
